• January 21, 2019 Regular meeting

- Borough Clerk: Clerk Bonin reported that he has sent to each council member the list of registered cats and dogs in the borough to assist with any animal which may get loose. And agendas on line
- Emergency Management/State Police/Millstone Valley Fire Department: Mayor Heck reported that he continues to work on the HMGP flood mitigation grant. One last home to do. Also working on current haz mit plan with county. One fire call this month and one ems call. No state police calls.

- Recreation Commission: Wendy Heck stated the Easter egg hunt will be on 4/20/19. Earth day clean up notice will be sent out to resident and put online.

COUNCIL REPORTS:

• Buildings and Grounds: no report



- Planning Board: Vincent Biviano stated the Planning Board would like to know who owns the Blackshear house. Mayor Heck stated that it is currently owned by the Blackshear, it has been recently deeded by another person.
- Traffic and Roads: Mayor Heck reported that on tonight's agenda is a resolution for a shared service with county for Van Doren drive.

A motion to accept the reports was offered by Councilman Biviano. Seconded by Councilwoman Smerdon.

MAYOR'S REPORT:

Mayor Heck reported he is working on hazard mitigation update. He is also working on a full scale cert exercise this year. Mayor Heck stated he would like to submit CDBG application for walking path for 2019 which will connect to other towns as a regional path. Prepping road projects this year to reduce costs and enable borough to do more with grant funds. Mayor Heck sated he is safety and compliance officer and has been recertified for 3 years. Mayor Heck and Council President Ross met to discuss sewers. Mayor Heck stated he went to court on abandoned properties and the owner was a no show, could be arrested. He also talked about the borough becoming a "receivership" for vacant property not owners. This would require a new ordinance. The Borough incurs costs to maintain homes even with liens on the property.

Attorney Offen stated we may need to amend our ordinance if we want to accept through receivership. Mayor Heck agreed stating our ordinance does provide for fines but does not allow much more.

MEETING OPEN TO THE PUBLIC:

Council President Ross offered a motion to open the meeting to the public. Seconded by Councilwoman Smerdon.

Rebbecca Newman, 25 Maple Terrace, asked how many quotes were received for trees, stating she submitted an OPRA request for the documents. Mayor stated he has those quotes. Ms. Newman asked how many homes are on the vacant home list. Mayor Heck stated 3 did not comply and one person is living in the house, the bank is not abandoned. Ms. Newman asked under what ordinance did we cut trees, Mayor Heck stated they were cut in preparation for road project. Mayor Heck explained the TTF funds cannot be used for tree removal. He consulted with county engineer and there is a plan to replace trees and all is part of road project. Ms. Newman asked about fire services inquiry. Mayor Heck stated that Council President Ross would respond to that as he is aware that the volunteers are on the project. Council President Ross stated the question list is with Hillsborough.

Mayor Heck asked Ms. Newman how the blue ribbon committee on the school savings is going. Ms. Newman stated she is not on any committee. Mayor Heck stated she accepted the task at a recent meeting. Mayor Heck stated that Hillsborough charges Millstone double and he asked Ms. Newman if she has any information about that matter. Ms. Newman stated she has no information

Zak Hubert, 1393 Millstone River Road, brought up the issue of shutters in driveway. He stated his intent to replace with historic shutters but has not received approval from the Historic Commission. He stated the pile of shutters in driveway are a hazard. Mayor Heck stated he toured and took pictures and that the historic commission stated that the application is incomplete. Mr. Hubert commented he has child and the property is unsafe. He commented that the hardware is historic



and Mayor Heck asked that the historic commission visit the home and make a quick decision. Mr. Huber stated it is not cost effective to repair shutters. Mayor Heck commented he will ask Portia Orton to send expert to review and deicide.

• A RESOLUTION APPOINTING THE MUNICIPAL COURT JUDGE FOR A THREE YEAR TERM



A resolution to appoint the municipal court judge was offered by Councilman biv . Seconded by Councilwoman Smerdon.

 A RESOLUTION REQUESTING PERMISSION FOR THE DEDICATION BY RIDER FOR DEVELOPER'S ESCROW FUND REQUIRED BY NJS 40:55D-53.1

A resolution requesting a dedication by rider was offered by Councilman Biviano. Seconded by Council President Ross.

WHEREAS, permission is required of the Director of the Division of Local Government Services for approval as a dedication by rider of revenues received by a municipality when the revenue is not subject to reasonably accurate estimates in advance; and

WHEREAS, NJS 40:55D-53.1 provides for receipt of Developer's escrow funds by the municipality to provide for the operating costs to administer this act; and

WHEREAS, N.J.S.A. 40A:4-39 provides the dedicated revenues anticipated from the Developer's Escrow Fund are hereby anticipated as revenue and are hereby appropriated for the purpose to which said revenue is dedicated by statute or other legal requirement.

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Millstone, County of Somerset, New Jersey as follows:

- 1. All Developer's escrow fees received by the Borough of Millstone, County of Somerset, State of New Jersey, shall be placed in a specific trust fund and such trust fund shall be considered a "Dedication by Rider" to the budget of the local unit, pursuant to N.J.S. 40A:4-39, for the exclusive purpose of depositing and expending escrow funds.
- 2. The Governing Body does hereby request permission of the Director of Division of Local Government Services to pay expenditures of the Developer's Escrow Fund as per NJS 40:55D-53.1 and pursuant to N.J.S.A. 40A:4-39.
- 3. The Municipal Clerk of the Borough of Millstone is hereby directed to forward two certified copies of this Resolution to the Director of the Division of Local Government Services.
- RESOLUTION AUTHORIZING CANCELLATION OF THE BOROUGH OF MILLSTONE'S "PUBLIC ASSISTANCE" BANK ACCOUNT AT TD BANK AND AUTHORIZING ALL FUNDS TO BE DEPOSITED INTO THE "CURRENT ACCOUNT" AT TD BANK

A resolution authorizing the cancellation of certain accounts was offered by Councilman Biviano. Seconded by Councilwoman Smerdon.

CFO Popick explained these are accounts that have existed for years but are unused therefore should be cancelled.

WHEREAS, the Borough of Millstone has a bank account entitled "Public Assistance" from when the Borough administered public welfare funds; and

WHEREAS, the Borough has not used this account for several years as the County has taken over administration of welfare assistance; and

WHEREAS, with the concurrence of the NJ Department of Community Affairs, Div. of Local Government Services and the Township Auditor, the Borough of Millstone intends to close the bank account and move the funds to the Borough of Millstone's "Current Account".

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Millstone, County of Somerset, New Jersey that the bank account entitled "Public Assistance" in the amount of \$2,404.28 shall be closed and all funds shall be deposited into the Borough of Millstone "Current Account"

• RESOLUTION AUTHORIZING CANCELLATION OF THE BOROUGH OF MILLSTONE'S "RECREATION COMMISSION" BANK ACCOUNT AT TD BANK AND AUTHORIZING ALL FUNDS TO BE DEPOSITED INTO THE "CURRENT ACCOUNT" AT TD BANK

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Borough Council of the Borough of Millstone do hereby approve an agreement with the County of Somerset for the purposes of resurfacing Van Doren Drive.

RESOLUTION TO ENTER INTO A SHARED SERVICE AGREEMENT FOR RECYCLING SERVICES WITH THE COUNTY OF SOMERSET

A resolution entering into a shared services agreement was offered by Councilman Biviano. Seconded by Councilwoman Smerdon.

WHEREAS, the County of Somerset entered into a negotiations regarding an agreement between the County of Somerset and each of the nineteen municipalities located within Somerset County; and

WHEREAS, the County of Somerset has agreed that the County fee shall be based upon the number of households within the municipality as determined by the County Planning Board at a rate of \$23.85 per household per year; and

WHEREAS, the County of Somerset has determined that it is in the best interests of the County to execute an agreement with each of the nineteen municipalities formulated as a result of negotiations.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Borough Council of the Borough of Millstone do hereby approve an agreement with the County of Somerset for the purposes of providing recycling pick up in accordance with the attached agreement for the period of January 1, 2019 to December 31, 2019.

• BUDGET DISCUSSION

CFO Popick stated that she anticipates a level budget and asked the Borough Council if they wish to add any items to the budget. Mayor Heck suggested to Mr. Huber, who is planning board chair, that they discuss the Planning Board budget. Mayor Heck asked that the planning board let the borough council know if there is a need for more money in their budget,



Mayor Heck stated that with the Hillsborough school vote, he is wary about the borough increasing our taxes with that looming.

OLD BUSINESS:

- Sewers Mayor Heck stated he, Council President Ross and Attorney Offen met with Van Cleef to review benchmarks and possible funding sources. Attorney Offen stated that the met last Friday. Mayor Heck added that he and Attorney Offen also met with Engineer Matt Loper earlier in the week as there were a few internal issues to work out. Van Cleef Engineering is going to do some initial sewer concept planning work for us. The Borough is also looking for possible grants and we may wish also consider a PILOT to help fund projects. Van Cleef is doing a PILOT in Frenchtown which may lay the groundwork for doing one in Millstone.
- FEMA Flood Mitigation Project Attorney Offen stated that the borough has done everything we need to do it is totally up to Mr. Kestner. Mayor Heck stated he has spoken to Mr. Kestner about a possible contingency plan if this does not happen. Mr. Kestner is working new financing. Attorney Offen stated there is nothing more the borough as to do to.
- Attorney Offen stated we have been sued by Selective Insurance. We have requested information for years and received none. It is for workers compensation services for which there is no information provided by Selective.
- Attorney Offen also commented that we have been appealing tax assessments with Verizon and there is a recent court case ruled against Verizon. We may be getting money eventually. We have appealed in the past so the borough his protected.
- Attorney Offen suggested the Borough Council adjourn into executive session for litigation and contract negations.

EXECUTIVE SESSION:

A resolution to enter into executive session at 8:30 PM was offered by Councilman Biviano. Seconded by Councilwoman Smerdon.
