#### RESOLUTION AWARDING A CONTRACT FOR SOLID WASTE COLLECTION

**WHEREAS**, on March 20, 2017 a Contract was awarded by the Borough Council, for ("Project") Solid Waste Collection Services to; Republic Services of NJ d/b/a Raritan Valley Disposal, 9 Frontage Road, Clinton, NJ 08809 and

WHEREAS, the terms of the Contract allows for two, one year extensions and in accordance with after the initial three year contract; and

**WHEREAS**, the Qualified Purchasing Agent and the Mayor recommend renewing this Contract for the first extension term of January 1, 2020 – December 31, 2020.

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Millstone, County of Somerset, State of New Jersey, that the Contract for the above referenced Project be extended for a one year term January 1, 2020 – December 31, 2020 in an amount not to exceed \$32,323.00.

#### • RESOLUTION AUTHORIZING MUNICIPAL ALLIANCE GRANT FOR FISCAL YEAR 2019-2020

WHEREAS, the County of Somerset has prepared a contract which would provide \$28,436.49 to Hillsborough Township for the provision of the Hillsborough/Millstone Municipal Alliance activities for prevention of alcoholism and drug abuse, and the Township would provide a 75% match of \$21,327.37 in in-kind services, and a 25% cash match of \$7,109.13 will be raised by the Municipal Alliance Committee or provided by the municipality, and a copy of the proposed agreement is on file in the office of the Township Clerk,

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and Council of the Borough Of Millstone, County of Somerset, that it hereby authorizes the Mayor and Clerk to sign the original of this agreement.

Clerk Bonin stated he uses this company in another community and has had a very good experience with the company.
